- **Reportable Injury** means an injury to any qualifying child while in care that results in death or the child receiving professional medical attention other than first aid provided by child care staff.
- **Serious Injury** means a reportable injury that occurred due to a health or safety noncompliance and indicates a deficiency in the operation or management of the program.
- **All Deaths**, including those caused by a medical event, must be reported to Child Care Licensing.
- **Substantiated Child Abuse** means that either Child Protective Services or Child Care Licensing found supportive evidence to substantiate the allegations.
- **NC** means the data is not collected or not available.
